In the event that repairs are not performed within 30 days of the agreed appointment date, any restocking fee or non-returnable parts will be billed to the person authorizing the repair.

**STORAGE**

Payment and removal of vehicle is required within 3 working days of the completion of repairs. Thereafter a storage fee of \$30.00 per day will be incurred. After 30 days the vehicle will be put up for public auction.

**WARRANTY**

Lacey Collision Center, Inc. does not warranty LKQ nor aftermarket parts, normal wear, negligence, nor abuse done tot he repaired vehicle. Do not wax painted surfaces for 60 days in summer and 90 days in winter. Wash vehicle with mild detergent. Failure to follow the above will leave this warranty null and void. Lacey Collision Center, Inc. is not responsible for damage to your vehicle or personal property due to fire, theft, or vandalism while on Lacey Collision Center property. After business hours, vehicles are locked behind the gates and patrolled regularly.
